Forgiveness is described as essential for maintaining communal harmony (Tutu, 2003, p. 48). Forgiveness was seen as a way to restore the broken relationship between God and His people, fostering justice and reconciliation (Adeyemo, 2000, p. 67).

Jesus emphasized the need to forgive others as God forgives (Mbiti, 2006, p. 112). Additionally, African theology intertwines forgiveness with *ubuntu* a concept that underscores interdependence and shared humanity. *Ubuntu* shapes the theological discourse on forgiveness, moving beyond retributive justice to embrace restorative justice, where forgiveness becomes a moral and spiritual duty (Louw, 2015, p. 87). Moreover, forgiveness mirrors God's unconditional love and mercy (Mugambi, 2003, p. 45). Mugambi notes, "In the African Christian context, forgiveness is both a theological virtue and a moral necessity for peace and cohesion" (Mugambi, 2003, p. 45). Forgiveness requires humility and a commitment to reconciliation, reflecting Christ's teachings in the Gospels. African theological perspectives on forgiveness reveal a dynamic interplay between biblical teachings and cultural values, underscoring its importance for personal, communal, and societal transformation. These insights enrich global theological discussions and demonstrate how forgiveness is deeply rooted in the lived realities and spiritual traditions of African communities.
