Research has shown that media biases and stereotypes can undermine the electoral prospects of female candidates, leading to diminished public trust and support. Consequently, gender disparities persist in political representation, limiting the advancement of gender equality and impeding democratic governance.

(Dill: 2017). "Gendered media encompasses the representation and symbolic imagery, narratives, and discourses that construct and communicate ideas about gender, influencing the ways in which individuals understand themselves and others in relation to gender identity, roles, and expectations." (Gill: 2007).

Gavey (2003) says that: "Gendered media can be understood as a complex network of media products and practices that contribute to the social construction of gender, influencing individuals' self-perceptions, attitudes, and behaviors, and perpetuating



gender inequalities." Bartsch & Moriarty (2019) say that: "Gendered media involves the examination of how media representations and narratives reinforce and challenge traditional gender binaries, norms, and stereotypes, influencing the construction of gender identities and social hierarchies". These definitions provide a foundation for understanding the concept of gendered media and its influence on society, highlighting its role in shaping attitudes, perceptions, and behaviors related to gender.

Gendered media can shape societal perceptions, influence cultural norms, and impact individuals' understanding of gender roles and identities. (Ross:2012) says that: "Gendered media encompasses the ways in which media institutions, practices, and discourses produce, reproduce, and reinforce gendered meanings, hierarchies, and power relations, shaping and influencing societal understandings of gender and influencing the construction of gender identities". Gill, R. (2007) offers a:"comprehensive exploration of gendered media representations and their effects on individuals and society:" The author critically analyzes various media forms, including advertising, news, and popular culture, to reveal how gender stereotypes are constructed, maintained, and challenged. Gill, R. (2007) work, examines the power dynamics at play in media industries and explores the implications of gendered media for social, cultural, and political contexts. Gill's work provides valuable insights into the complexities of gendered media and its impact on gender equality and representation. Dill and Thill (2007) examine the: "gendered portrayals of characters in video games and the impact on young individuals' perceptions of gender roles". It demonstrates how media, in this case, video games, can contribute to the socialization of gender norms and reinforce stereotypes. The study highlights the importance of critically analyzing gendered media representations and their potential influence on individuals' beliefs and attitudes.

Gendered media plays a significant role in shaping societal perceptions, constructing and reinforcing gender norms, and influencing individual attitudes and behaviors. ## **Female Politicians**

Krook & O'Brien, (2021) say that: "Female politicians are women who are engaged in the formal political arena, seeking to exercise political power, influence policies, and represent their constituents' interests, challenging gender biases and promoting gender equality in the political realm." Nigeria is one of the countries that has been a largely male-dominated society and almost everything has been about the men taken a closer look at the last concluded presidential elections, Ago-Iwoye, from Nigeria wrote a report that was published by Rahma Jimoh On 16 Feb 2023on Aljazeera. The report is posted here as it was written and it was written that:

-----On June 8, 2022, millions of Nigerians were glued to their phones, televisions, and other devices, watching the presidential primaries of the ruling All Progressives Congress (APC). Then something happened. Uju Ken Ohanenye, the only woman among the 23 aspirants, withdrew from the contest in favor of the eventual winner and national leader of the party, Bola Tinubu. "I have decided to step aside for the lifesaver who is Asiwaju Bola Ahmed Tinubu," the lawyer and entrepreneur who had previously told journalists that "the touch of a woman is lacking in the governance of this country", said on national television. For some Nigerians, it was a step back for gender equality in the country's politics but also a timely reminder of the many hurdles women face in attaining leadership roles in this vast West African country. "[Ohanenye] might have believed she was not going to win because of the financial and political limitations she would have to surpass," said Antoinette Lecky, Lagosbased media personality and former projects lead at "Elect Her", a nonprofit organization focused on getting more women into political leadership. "[But] it gave her a chance to publicize herself as a lot of people did not know who she was at the time."Half of Nigeria's estimated 210 million people are women. But only one woman has ever occupied any of the top four positions in Nigerian governance – a five-month stint as speaker in 2007 – since the country's independence from Britain in 1960. Only five percent of Nigeria's federal lawmakers are women, one of the lowest representation rates globally. And no woman has ever been elected governor. Traditional African societies from experience show that women have been marginalized and discriminated on from realizing their full potentials outside their already known domestic responsibilities. The one's who dared to come out are many a times bullied into resigning and hiding back inside their net. Sally Osei-Appiah (2019) noted that:

Women politicians have long been marginalised in the political arena, aided in part by gender roles which prescribe what a woman can and cannot do, and patriarchal systems which establish, reinforce and sustain these roles.

Increasing the visibility of women politicians is therefore a form of contestation against these structural barriers. It breaks the male dominance in politics while serving



as a reference point to encourage more women into politics. However, studies on women politicians' media coverage point to gender biases that favour male politicians in both quantity and quality. While coverage of male politicians is generally issue-based, demonstrating their policy views, that of female politicians is refracted through the gendered lens of marginalisation and sexist reporting. Given the increasing mediatisation of contemporary politics, a trend that has positioned the media as the prime provider of political information, this media bias against women politicians undermines not only their political careers but also the very fibre of representative democracy

O'Neill et al(2016) note that "women politicians are typically portrayed through "misogynistic gendered stereotypes or frames".

## **Media bias**

Media bias could be defined as the unjust favoritism and reporting of a certain ideas or standpoint from one's personal view or view of others. Media bias according to study.com (2021) occurs when a journalist or news outlet allows opinions to affect the news they report. Iyengar, (2015) says that: "Media bias refers to the systematic and consistent favoritism, omission, or distortion of information in news reporting, reflecting journalists' implicit or explicit preferences and potentially influencing audience perceptions and attitudes." Media criticism is the act of examining and analyzing what goes on inside the media. Media bias can exist in various forms and can impact how female politicians are portrayed in Nigeria or any other country. Media bias can manifest in several ways, some of them are:

- a. Stereotyping: Female politicians may be subjected to stereotypes or traditional gender roles, leading to biased coverage. They may be portrayed as weak, emotional, or incapable of holding leadership positions, which can undermine their credibility
- a. Focus on appearance: Media may disproportionately focus on the appearance and fashion choices of female politicians, rather than their policies or accomplishments. This emphasis on superficial aspects can overshadow their political abilities.
- b. Underrepresentation: Female politicians may receive less media coverage compared to their male counterparts. This lack of representation can contribute to a skewed perception of their involvement and influence in politics.
- c. Harsh scrutiny: Female politicians may face higher levels of scrutiny and criticism compared to male politicians. They may be judged more harshly for their actions, speech, or personal lives, leading to an unfair portrayal in the media.
- d. Lack of diversity: The voices and perspectives of female politicians from diverse backgrounds may be underrepresented in the media, further reinforcing existing biases and stereotypes.

It is important to consume news from a variety of sources to gain a more balanced understanding of how female politicians are portrayed in Nigeria. Critical media literacy skills can help individuals identify and challenge any bias they encounter in the media. Media bias can stem from a variety of factors, including personal beliefs



and values of journalists, corporate ownership and control, audience preferences, and political pressures. Here are some common causes of media bias along with references and citations to support them:

- a. Journalists' personal beliefs and values: Groseclose (2005) says that "Journalists are human beings with their own perspectives, beliefs, and values, which can unintentionally influence their reporting". Research suggests that journalists tend to have liberal or left-leaning views, which can result in bias in their coverage.
- b. Corporate ownership and control Bagdikian (2004) says that "media outlets are often owned by large corporations with their own interests and agendas". Corporate ownership can influence news coverage by promoting certain narratives that align with their business or political interests.
- c. Audience preferences: Prior (2007) notes that: "media organizations strive to attract and retain viewers, readers, or listeners". As a result, they may tailor their content to appeal to their target audience, leading to bias in reporting. Sensationalism and the desire for higher ratings can influence the selection and presentation of news stories
- d. Political pressures: McChesney (2004) is of the opinion that: "Governments, politicians, and interest groups can exert pressure on media organizations to shape their coverage in a particular way". This can include influencing the framing of stories, suppressing certain viewpoints, or encouraging favorable coverage.

It is important to note that media bias is a complex and multifaceted issue, and the causes mentioned above are not exhaustive. The interplay of these factors can vary across different media outlets and contexts, resulting in a nuanced landscape of bias in media reporting. Many atimes gender bias tend to favor men more because seem to be the one's at the receiving end especially female politicians.

### Misogyny

The term "misogyny" according to Merriam-Webster Dictionary was derived from the Greek words "misos," meaning hatred, and "gyne," meaning woman. It gained prominence in feminist discourse during the second wave of feminism in the 1960s and 1970s, as scholars and activists sought to analyze and challenge the deep-seated biases and prejudices that perpetuated gender inequality. "Misogyny can be understood as a system of beliefs, attitudes, and practices that devalue and marginalize women, reinforcing gender hierarchies and limiting women's opportunities and rights." (Allen, 2018) "Misogyny can be understood as a deep-seated and widespread hostility toward women, manifesting in various forms of discrimination, prejudice, and violence, which is rooted in patriarchal systems and seeks to maintain male dominance and control." (Hooks, 2004) Misogyny refers to the hatred, contempt, or prejudice against women or girls.

In the context of gendered images, misogyny can be observed in various ways, such as objectification, sexualization, and the reinforcement of harmful stereotypes. Misogyny is a deep-rooted prejudice, contempt, or hatred towards women or girls. Objectification and Sexualization Glick & Fiske (1996) were of the opinion that "Women are often depicted in media and advertising as objects of sexual desire, emphasizing their physical appearance rather than their abilities, skills, or intellect". This objectification reduces women to mere objects for the pleasure or consumption of others, perpetuating gender inequality and reinforcing harmful power dynamics.
- b. Stereotypes and Limited Representations Ross (2008) says that: "Gendered images often reinforce stereotypes and limit the representations of women". This can include portraying women as overly emotional, dependent, or solely focused on domestic roles. Such representations not only limit the diversity and complexity of women's experiences but also contribute to societal expectations that restrict their opportunities and perpetuate inequality.
- c. Violence and Victim-Blaming: Hall, N et al (1997) are of the opinion that: "Misogynistic images may depict violence against women or perpetuate victim-blaming attitudes". These portrayals normalize or trivialize violence, contribute to a culture of victim-blaming, and undermine efforts to address gender-based violence and support survivors.
- d. Double Standards and Pressure: Fredrickson, B. L et al (1996) say that: "Gendered images often enforce double standards, prescribing different expectations and standards for women compared to men". Women may face pressure to conform to narrow beauty ideals, maintain a particular body shape, or adhere to traditional gender roles, reinforcing societal expectations and perpetuating gender inequality.

It is important to challenge and critique gendered images that perpetuate misogyny. By promoting diverse and empowering representations of women and advocating for media literacy, we can work towards a more inclusive and equitable society. Stopping gendered misogyny against women requires collective efforts at various levels.

#### Conclusion
