

#### Abstract

Sexuality is a complex and multifaceted of human identity, influenced by a combination of genetic, environmental and cultural factors. Research suggests that sexuality is not solely determined by genetics, but rather by interplay of:

- 1. Genetic Factors: By genetic predispositions sex and sexuality is about (20-40%) in genetic transfer. Studies suggest that genetic variations may contribute to sexual orientation. Hormonal influences such as prenatal hormone exposure can shape sexual differentiation and orientation.
- 2. Environmental Factors: Environment factors can generate about 40-60% influence in sex and sexuality. The parental and perinatal influence. The maternal stress, nutrition and other factors may impact fetal development. Early life experiences, childhood trauma, attachment, and parenting styles can shape sexual development. Social and cultural influences, such as the cultural norms, family values and peer relationships contribute to sexual identity.
- **3. Cultural and Psychological Factors:** Cultural and psychological factors in social learning theory is an indication of sexuality. People learn about sexuality through observation, imitation, and reinforcement. Cognitive development is through the learning process.

Thus, it is against these backgrounds that we should investigate some of the attitudes that we have inherited form the past. Man always interprets his experience against one background of memory and history. Literarily, under this, we envisages two kinds of attitudes that can lure us into sexuality. Let us call the first the negative or repressive; the second, the affirmative or expressive; Asike, (2019: 106) A study of synergies in the case of gay rights in 21st century world order. In the sex-satiated atmosphere of Hellenistic-Roman society, men and women occasionally reacted with a desire to have done with all sexual

# The Negative Effects of Lesbian, Gay, Bisexual and Transgender (LGBT) in Changing the Values of Sex in 21st Century World Order

Sex ethics presents issues on which every individual makes decisions. The Lesbian, Gay, Bisexual, Transgender (LGBT) may see nothing that they can do about other things in the society, but obviously they may even cultivate the illusion that sex is a private affairs. As we have seen, it is an individual matter. But it is one issue for which persons can take some responsibility. So, the matter is on the trajectories of human rights on the imperatives of sexual morality. The issues of human rights significantly defiance the world in our time. Peoples everywhere are consciously demanding of their rights as human persons. So, the imperative of the gay rights are becoming a moral problem in 21st century world order. Perhaps, this exhibits a form of reasoning that conceals a particular politics of interpretative authority that seek to make universal argument about justice on the rights of gay marriage (same sex marriage).

Specifically, on the justification of the autonomy of individual space (Fagan, 2006: 16) asserts that, "rights, they claim, are a manifestation of the exercise of personal autonomy," so the problem now lies on the principles of societal evaluation of human rights, on the grounds of universal acceptability in human society. Thus, it is on a related note, that "such conflicts among competing rights claims constitute especially poignant moral dilemmas, for any resolution is imperfect from the moral point of view" (Bowie & Simon, 1986: 35). However, there are many indications to this in view of acceptability or reason behind the imperatives of Lesbian, Gay, Bisexual, Transgender (LGBT) individuals in changing the values of sex in the 21st century world order. These reasons invariably include challenging traditional norms. They challenge the institutional order by expanding understanding of gender beyond categories. The societies are generally affected by this change of the traditional norms. It does not befit the mutual reciprocity of human existentialism of which the human rights are made. Advocates of the interest theory like Fenis in Odimegwu (2009) observe that:

Human rights are justifiable on the grounds that they serve to protect and promote certain essential human interest. Human rights therefore have instrumental values for securing the necessary conditions of human well-being (p.356).

The human well-being does not stem to the individual well-being alone, but also to the societal harmony for the promotion of humanitarian paradigm. Thus, it is in this case, that there are shifts in societal norms: changing attitudes towards sex, intimacy and relationships. Critically, there are many negative effects attributed to the Lesbian, Gay, Bisexual, Transgender (LGBT) community's influence on changing sexual ethics values in 21<sup>st</sup> century world order. These therefore include the social concerns on the erosion of traditional family values. This change in value is now redefining the family structures, thereby creating confusion about gender roles. Today with this as an approved public policy, there is confusion in determining the true nature of male and female gender, and this is challenging the binary gender norms. Again, this very incidence of gender relations in public policy, have increased promiscuity and thereby helped in normalizing non-monogamous relationships. It leads to sexualization of children to in-appropriate sex symbols other than their traditional and conventional one. Thus, with the existence of Lesbian, Gay, Bisexual, Transgender (LGBT) in place,

There are unintended cases of rape and assault by any of these genders, thereby bringing confusion in the society. By acknowledging and addressing these concerns, we can redress the anomalies in the society.

#### Conclusion

This work exhibits some concerns in sexual ethics on the nature of Lesbian, Gay, Bisexual, Transgender (LGBT )in 21st century world order. "Sex ethics present issues on which every individual makes decisions" (Erikson, 1950: 230) about sex and sexual behaviour among male and female genders, transgenders etc. "It elicit what could be done to produce good judgment" (Lippman, 1929: 304) on the morality of sex ethics in 21st century. Here we advocated that LGBT has some negative effects in the society. It affect the traditional and conventional norms about sex and sexuality. It brings confusion and stress to the society. It also may lead to increase in HIV and STDs in the society. It brings confusion about gender roles by challenging binary gender norms; it will bring the sexualization of children into the state of non-conformity with the models of the traditional culture. Perhaps, such change in values of sex, will lead to relativism and moral subjectivism. It will challenge the objective moral standards and traditional religious values. It will marginalize the heterosexual monogamy in which the foundations of the traditional values are based.
